
Rules for Nomination and Election

1. The Model A Restorers Club, Inc. (MARC) has been requested by the Model A Ford Foundation, Inc. (MAFFI) to submit one nominee by June 30 of each year for induction into the Model A Ford Museum Hall of Fame (HOF), located on the campus of the Gilmore Car Museum, Hickory Corners, Michigan.
2. The purpose of this Committee is to develop a narrative based on the performance of two MARC members who qualify for nomination as set forth in the rules of this document and to submit said nominees to the MARC Board of Directors (BoD) for approval or rejection. Pending approval of at least one of the nominees, the Board will choose one nominee for election to the MAFFI Hall of Fame and submit that nominee to the MAFFI Hall of Fame Review Board and ultimately to the sitting Trustees of MAFFI for their approval or rejection. Should the nominee be rejected, MAFFI will contact the Committee chair for a review and submittal of another nominee.
3. While MAFFI has established criteria to induct four individuals to its Hall of Fame each year, there will be only one inductee from MARC and one from the Model A Ford Club of America (MAFCA); the two remaining inductees will be chosen by MAFFI. The inductees from MARC and MAFCA will be based the Model A Ford Hobby area while MAFFI inductees will be based on the Model A Ford Production/Preservation area.

4. This Committee is charged with the thorough vetting of proposed individuals as candidates for the HOF nomination, gathering pertinent information, assembling the information, and submitting the documentation to the MARC Board of Directors for review and approval or rejection. Pending approval by the MARC BoD, this Committee will be responsible for completing the required MAFFI Nomination Form and submitting to the MAFFI HOF Review Board. Should the MAFFI HOF Review Board require additional information or request changes to the submitted documentation, the Committee will be responsible for any corrections, additions or deletions and for resubmitting to the MARC BoD in a timely manner.

5. MAFFI has defined the criteria for nomination, in part, as follows: *To be nominated for the Hall of fame, a candidate must have a strong connection to some aspect of the Model A Ford – including such activities as the design, development, manufacture, sales, maintenance, accessories, commercial modifications, industrial applications, restoration, history, preservation, publications, and recreational utilization.*

6. While it is encouraged that the criteria in Item 5 (above) be utilized to its fullest, it should be further noted that the candidates submitted by the Committee must be chosen based on their exclusive contributions to the Model A Restorers Club. Individuals who have contributed to the Model A Ford hobby in general, or who have been active in other clubs or through organizations other than MARC, shall not be eligible for nomination by this Committee or through MARC.
